2 Mode & Method of Submission of Tenders

Tender must be submitted in sealed main envelope cover containing four separate sealed envelope containing Cost of Tender document with down loading certificate(Annexure –V), EMD, Part- I (Annexure –I) and Part-II(Annexure –II). The Tenderer who are exempted from submitting EMD, on the basis of a certificate issued by Govt. authorities should submit their Certificate in separate envelop with mentioning on top of it “EMD Exemption Certificate”. These envelopes should be submitted in separate form. On the main envelope cover, the tenderer must be scribed with the Tender name, Tender enquiry number and the date of opening at top of envelope and tenderer name & address at bottom left of envelope. All envelopes containing the tenders shall be properly sealed.

The Tender is to be submitted in four envelopes viz. Cost of Tender document with down loading certificate, EMD, Part- I and Part- II in separate sealed envelope super scribed by Cost of Tender document with down loading certificate, EMD or EMD exemption certificate, Part –I and Part –II as shown below

Part- I: Consisting of technical offer and commercial Terms & Conditions. The Part-I bids of only those tenderers whose EMD is acceptable will be opened.

Part- II: The second part of the tender shall consist of details of Prices only. The price bids of only those tenderers whose offer in Part –I is found to be techno – commercially acceptable will be opened.

3. Validity Period of Tenders:

The rates, terms and conditions offered shall be valid for a period of 120 days from the date of opening of the tender.

5 Opening of Tender:

The tender shall be opened at the office of HOD (UG), CMPDI, RI-V, SECL Office Complex, Seepat Road, Bilaspur 495 006, at the time and date as given in the NIT.

(If the tender is not opened on the above date due to unforeseen circumstances, then it will be opened on the next working date.)

- 6. (a) The prices quoted must be firm till delivery. The prices offered should be given preferably both in words and figures.
- 6(b) Printed terms and conditions of the vendor shall not be considered. Tenderers are requested to submit their offer complete in all respects maintaining serial number of items, terms and conditions as per the tender documents along with all supporting documents failing which offer may not be considered and no further clarification on technical commercial aspects may be entertained.
- 6 (c) Delivery periods shall be mentioned in the supply order.
- 6(d) Payment terms are as per general conditions of contract and are enclosed with this tender notice.
- 6(e) Supply Order, if placed, will be subject to the terms and conditions given separately.
- 6(f) Normally no deviation is acceptable to our tender documents & Terms and Conditions. Tenders which have deviations are liable for rejection without making any back reference to the tenderers. Tenders asked for must be submitted complete in all respects.
- 6(g) Self-attested copies of order received from subsidiaries of CIL, if any, for the quoted items should be submitted along with the quotation in the Part -1 bid. List of past supplies with the details of order reference and the performance report, if any, should be furnished along with the offer.
- 6(h) All disputes are subject to Bilaspur (CG) Court Jurisdiction only.

7. GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF OFFERS

- a. The complete offer should be typed/hand written on the letter head of the tenderers. If firm's letter heads are not sufficient to accommodate technical and pricing details, preferably bigger papers should be used, such sheets along with other pages of the offer should be signed and stamped by company's authorized representative/official.
- b. **All pages of tender documents should be signed and must have company's seal. This is a must.**
- c. Quotations, erased and over written, will be summarily rejected unless corrections are authenticated with the tenderer's signature.
- d. CMPDI reserves the right to reject or accept or withdraw the tender in full or part as the case may be without assigning reason thereof. Tenderers are advised to carefully note that the deviation in these terms will not be entertained.
- e. Party are required to submit offer for all the items as envisaged in the schedule of requirement (Annexure – I)
- f. Bid evaluation: - Parties are required to submit their offers as per Price Bid format (Annexure II). However bids shall be evaluated on overall the lowest (L-1) rate basis.

8. OTHER TERMS AND CONDITIONS

- i. **Prices:** - Rate shall include all taxes, duties, levies, insurance, packing and forwarding, transport and delivery at CMPDI, RI-V, Bilaspur (CG). If specifically not included in the offer, it will be assumed that these included in the offer.
- ii. **Payment:-** 100% payment will be made within 21 days after supply of materials and submission of bill and acceptance of material by the consignee.
- ii. **Delivery Schedule:** - The delivery schedule shall be in single lot within 30 days from date of supply order.
- iv. **Guarantee / Warranty:** - The guarantee / warranty should be given against any manufacturing defects in specifications and poor work man ship for carrying out trouble free drill operation with mechanical as well as hydraulic drills.

- v **Inspection :- :-** Inspection of material will be carried out at Stores, RI-V, CMPDI Bilaspur after receipt of materials. If material is not as per our specifications the same will be rejected and supplier shall replace material at their own cost.
