- 1 **Earnest Money** ₹2,500/- (₹Two thousand five hundred only) *as Earnest Money* is to be deposited in the form of A/c Payee Bank Demand Draft of any scheduled Bank in favour of CMPDI, Regional Institute- V, Bilaspur (CG). A/C payee Demand Draft should be submitted in separate envelop apart from Part-I and Part-II envelopes with the offer. The EMD of all bidders will be refunded as promptly as possible after opening of price bid and finalization of the tender. EMD shall bear no interest.

2 **Mode & Method of Submission of Tenders**

Tender must be submitted in sealed main envelope cover containing three separate sealed covers Part- I, Part- II and EMD. The Tenderer who are exempted from submitting EMD, on the basis of a certificate issued by Govt. authorities should submit their Certificate in separate envelop with mentioning on top of it “EMD Exemption Certificate”. This envelop should be submitted in separate form ( i.e. apart from Part-I and Part-II envelop). On the main envelope cover, the tenderer must be scribed with the Tender name, Tender enquiry number and the date of opening at top of envelope and tenderer name & address at bottom left of envelope. All envelopes containing the tenders shall be properly sealed. The Tender is to be submitted in three envelopes viz. (If the tender is not opened on the above date due to unforeseen circumstances, then it will be opened on the next working date.)

- 6. (a) The prices quoted must be firm till delivery. The prices offered should be given preferably both in words and figures.
- 6. (b) Period of rate contract is 1 year from the date of supply order or the final delivery of last gas cylinder whichever is earlier.
- 6. (c) Printed terms and conditions of the vendor shall not be considered. Tenderers are requested to submit their offer complete in all respects maintaining serial number of items, terms and conditions as per the tender documents along with all supporting documents failing which offer may not be considered and no further clarification on technical commercial aspects may be entertained.

- 6.(d) Supply Order once placed, will be subject to the terms and conditions given separately.
- 6.(e) Normally no deviation is acceptable to our tender documents & Terms and Conditions. Tenders which have deviations are liable for rejection without making any back reference to the tenderers. Tenders asked for must be submitted complete in all respects.
- 6(f) All disputes are subject to Bilaspur (CG) Court Jurisdiction only.

#### **GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF OFFERS**

- a. The complete offer should be typed/hand written on the letter head of the tenderers. If firm's letter heads are not sufficient to accommodate technical and pricing details, preferably bigger papers should be used, such sheets along with other pages of the offer should be signed and stamped by company's authorized representative/official.
- b. Quotations, erased and over written, will be summarily rejected unless corrections are authenticated with the tenderer's signature.
- c. CIL/Subsidiary reserves the right to reject or accept or withdraw the tender in full or part as the case may be without assigning reason thereof. Tenderers are advised to carefully note that the deviation in these terms will not be entertained.
- d. Bid evaluation: - Parties are required to submit their offers as per Price Bid format (Annexure-II). However bids shall be evaluated on item wise lowest rate (L-1) basis.
- e. If any payment has to be made by the CMPDI, RI-V, Bilaspur (CG), regarding collection charges and delivery of cylinder, the same amount shall be deducted from the bill of the party.

#### **OTHER TERMS AND CONDITIONS**

1. **Prices:** - Rates shall be exclusive of taxes, transportation, cylinder leakage (safety) test or any other additional cost and as per price bid (Annexure II).
2. **Payment:** - 100% payment will be made within 21 days after supply and submission of original bill in triplicate alongwith challan and acceptance of material by the consignee.
3. **Delivery Schedule:** - The delivery schedule of the refilled cylinder shall be within 30 days from collection date of empty cylinder from Env. Lab, RI-V, Bilaspur.
4. **Inspection:** - Inspection of material will be carried out at Env. Lab, RI-V, CMPDI, Bilaspur after receipt of materials. If material is not as per our specifications the same will be rejected and supplier shall replace material at their own cost. If any damage occurred in Spectrophotometer (AAS) due to impurity of gases, the damage charge will be adjusted from the bill.
