2 Mode & Method of Submission of Tenders

Tender must be submitted in sealed main envelope cover containing four separate sealed envelope containing Cost of Tender document with down loading certificate(Annexure –V), EMD, Part- I (Annexure –I) and Part- II(Annexure –II). The Tenderer who are exempted from submitting EMD, on the basis of a certificate issued by Govt. authorities should submit their Certificate in separate envelop with mentioning on top of it “EMD Exemption Certificate”. These envelops should be submitted in separate form. On the main envelope cover, the tenderer must be scribed with the Tender name, Tender enquiry number and the date of opening at top of envelope and tenderer name & address at bottom left of envelope. All envelopes containing the tenders shall be properly sealed.

The Tender is to be submitted in four envelops viz. 6. (a) The prices quoted must be firm till delivery. The prices offered should be given preferably both in words and figures.

6(b) Printed terms and conditions of the vendor shall not be considered. Tenderers are requested to submit their offer complete in all respects maintaining serial number of items, terms and conditions as per the tender documents along with all supporting documents failing which offer may not be considered and no further clarification on technical commercial aspects may be entertained.

6 (c) Delivery periods shall be mentioned in the supply order.

6(d) Payment terms are as per general conditions of contract and are enclosed with this tender notice.

6(e) Supply Order, if placed, will be subject to the terms and conditions given separately.

6(f) Normally no deviation is acceptable to our tender documents & Terms and Conditions. Tenders which have deviations are liable for rejection without making any back reference to the tenderers. Tenders asked for must be submitted complete in all respects.

6(g) Self-attested copies of order received from subsidiaries of CIL, if any, for the quoted items should be submitted along with the quotation in the Part -1 bid. List of past supplies with the details of order reference and the performance report, if any, should be furnished along with the offer.

6(h) All disputes are subject to Bilaspur (CG) Court Jurisdiction only.

7. GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF OFFERS

a. The complete offer should be typed/hand written on the letter head of the tenderers.
