### **NOTICE INVITING TENDER**

Sealed offers are invited from the experienced contractors for obtaining competitive rates for providing water from the nearest source to drill machines in various drilling blocks under **Madhukunda Sub-Camp, Dist: Purulia under CMPDI, RI-I** in the prescribed tender document for the following work.

Tender No.	:	CMPDI/RI-I/Expl./Drill water/Madhukunda/15-16/165-14	Dt. 10/06/2015
Description of work	:	Providing water from 6.00 AM to 6.00 PM to departmental trucks from the nearest water source through your supply pump including running, maintenance of pump, security, cost of water, diesel etc. for drill machines under Madhukunda Sub-camp, CMPDI, RI-I.	
No. of Drill Machines	:	At present, six nos. of drill machines are deployed at Madhukunda Sub-camp. It is expected that for July'2015 onwards, there will be four nos. of drilling machines under Madhukunda Sub-Camp.	
Source of Supply	:	The contractor shall have to provide independent source of supply along with supply-pumps for every drilling block. The source of supply shall not be more than 10 km from the site of drilling. However, if the drills deployed in more than one drilling blocks are within 10 km from the water supply source, they shall be catered by one source and rates shall accordingly be applicable.	
Validity of Rates	:	The finalized rates shall be valid for 1 year from the date of issuance of formal work order in that regard. The validity of rates may be extended for 1 year on satisfactory performance.	
Issuance of work order	:	Subsequent to finalization of competitive rates, appropriate work orders shall be issued for existing scenario of drill deployment. As soon as the deployment scenario changes, the existing work order shall be cancelled and fresh work order issued relevant to the changed scenario of drill deployments. The work orders may be issued any time within the validity period of the awarded rates.

**TERMS AND CONDITIONS**

1.	Charges for providing water from the nearest source is inclusive of all costs like water source, security, installation, maintenance, diesel, lubricants etc. required for operation of supply pump.
2.	Water should be supplied as per requirement continuously between 6.00 AM to 6.00 PM properly without any interruption.
3	In case of satisfactory performance towards water supply, the work order may be extended further for a period of one year or so as deemed fit by the management.
4.	In case of failure to provide water due to any reason, alternate arrangement shall be made immediately, failing which deduction of penalty charges at double the rate of accepted daily charges shall be made from bill. In case of part water supply, payment will be made on the basis of proportionate rate per day. In case the owner fails to provide water for a continuous period of 15 days, the contract shall stand terminated automatically from the 16 <sup>th</sup> day. In such case, the penal charges shall be deducted as per the rate mentioned above and adjusted from the security deposit.
5.	The management does not bear any responsibility whatsoever for repair, maintenance etc. of supply pump used for providing water. The security of the supply pump will be the responsibility of the owner.
6.	CMPDI management do not bind themselves to engage the services for providing water throughout the month/period of work order. Expected duration of contract would be about 357 days in a year. No claim regarding increase of rate/change of any terms and conditions would be entertained during the period of work order.
7.	No advance payment will be made by CMPDI. Payment for providing water will be made on monthly basis through A/c Payee Cheque against pre-receipted bill raised by the party and duly certified by the Officer-in-Charge of the Camp.
8.	CMPDI, RI-I management also reserves the right to terminate/foreclose the contract on a 15-day notice to the owner without assigning any reasons, whatsoever.
9.	Security deposit shall be 10% of awarded value of the job for the contract period. EMD shall be adjusted against security deposit. Recovery of balance security deposit after adjusting the EMD will be made from the first 4 monthly bills. Total security deposit will be refunded on successful completion of the work. The security deposit shall carry no interest.
10.	Income Tax will be deducted as per rules. Bidders are required to submit copy of the income tax PAN along with the offer.
11.	The Management reserves the right to accept or reject any or all the offers without assigning any reason whatsoever.
12.	1) Service Tax Registration no. is required to be submitted by the Tenderers. Prima facie, it is their responsibility to deposit service tax on the applicable value of services and can be claimed/ reimbursed on submission of valid documents like challan copy etc. 2) For those tenderers, who are exempted from the service tax registration, shall have to submit an affidavit to the effect that their annual income has never exceeded Rs. 9 lakhs in the previous Financial Year as well as the current Financial Year.
13.	<b>Wages &amp; workmen compensation: :</b> i) The Contractor should ensure that payment of wages to the workers to be engaged by him should not be less than the minimum wages, as notified by the Ministry of Labour, Govt. of India from time to time as applicable to the area in which the workers will be engaged. Wage payment to the workers should be made through cheque. ii) Job cards should be issued to each of the workers engaged by the contractor. iii) The contractor/contractors shall make necessary payments of Provident Fund for the workmen employed by him/them for the work as per the terms prevailing under provisions of CMPF and allied scheme. iv) The contractor will ensure that all workers employed by him get one day off per week. If the worker/workers has/have to work on all seven days of the week, he/they shall be paid double wage for the seventh day. v) The bidder will obtain "Workmen's Compensation Insurance" to all the persons employed by them as per statutory rule. vi) The bidder will indemnify CMPDI from all claims for injuries caused to any person whether a workman or not, while in or upon the works or the site of the same and CMPDI shall not be bound to defend any claim brought under the Workmen Compensation Act. Neither CMPDI management will be held responsible towards any dispute in this respect.

14.	<p><b><u>Claiming of Bills:</u></b></p> <p>i) The contractor, if not already registered, after receiving the work-order for the above job shall apply to the Regional Commissioner, CMPF, Region III, B B College Road, Ushagram, Asansol-3 for registration of contractors under CMPF through the Regional Director, RI-1, Asansol.</p> <p>ii) While claiming of the bill the contractor shall have to enclose the copy of the payment register showing the names of the workers, category of workers, number of working days per month, signature of the worker employed by him and the wages paid to them, duly certified by the OIC, Madhukunda Sub-Camp, Dist: Purulia under CMPDI, RI-I .</p> <p>iii) The claimed bill shall be paid after deduction of admissible CMPF for each workmen deployed by the contractor. The above deducted CMPF shall be deposited in the CMPF account of the concerned worker.</p>
15.	In case of failure to provide satisfactory services, the security deposit is liable to be forfeited, in addition to penal charges, if deemed fit by the management.
