Quotation must be submitted in sealed covers super-scribing “**REPAIRING OF 15 HP KIRLOSKAR MAKE PUMP, TYPE – DSM 2E, S/N. 1721702016 INSTALLED IN PUMP HOUSE**”, Quotation Number, Date & Time of Opening” and should be dropped in the nominated ‘**TENDER BOX**’ kept in the office of the **CM (E&M)**, CMPDI, RI-1, Asansol. Last date of submission of offer will be **15-July-15 up to 01:00 PM**.

2. Sealed quotation shall be opened on **15-July-15** at **03.30PM** in presence of the bidders or their authorised representatives . Authorized Representative must produce a power of attorney in his favour.

3. The offer shall be accompanied with the copies of :-

- a) Valid Trade license
- b) Electrical wireman certificate
- c) VAT Registration Certificate
- d) PAN No.
- e) Credentials for experience with supporting documents.

4. The quotation should indicate rate per unit, discount, if any, total price and delivery terms. The rates of taxes and duties applicable should be quoted.

5. The price quoted must be firm and offers must remain open for acceptance for six months from the due date of opening of the quotation.
