NOTICE INVITING TENDERS

2.0 Availability of Tender Document

2.1 Tender Documents can be obtained from the office of the E&M department CMPDI, RI VI on any working day between 10.00 Hrs to 13.00 Hrs after payment of tender document fee at the cash office of RI-VI, Jayant. Earnest money has to be deposited either in cash at Cash office or in the form of Demand draft on a Scheduled Bank in favour of "CMPDI Ltd., Regional Institute , Singrauli", payable at 'Morwa/ DUDHICHUA/JAYANT'.

2.2 Tenders downloaded from websites :-

Complete Tender Document can also be downloaded from CMPDI's web site <http://www.cmpdi.co.in> or Government of India web site www.tenders.gov.in.

Any tenderer, who desires to download the tender document from website and submit the tender on due date and time, may do so subject to the condition that they have to deposit the cost of tender document in form of Demand Draft drawn on any nationalized/scheduled bank payable to 'CMPDI Ltd., Regional Institute Singrauli' Payable at 'Morwa/DUDHICHUA/JAYANT'.

The company shall not be responsible for any delay/difficulty/inaccessibility of the downloading facility or any reason whatsoever. The downloading facility shall be available during the period of sale of tender document/paper.

The bidders who have downloaded the document from the websites will be required to submit an undertaking (Annexure-I) that they will accept the tender document as available in the website and their tenders shall be rejected, if any tampering in the tender document is found to be done, at the time of opening of tender.

The Bank Draft towards the cost of tender document (Application Fee) and the undertaking of the tenderer as per Annexure-I shall be submitted in Envelope-I along with the other documents as specified in Sl. Nos. 3.0 (Minimum eligibility criteria) and 4.0 (Submission of offer).

In case of any discrepancy between the tender document downloaded from the website and the master copy available in the office, the latter shall prevail & will be binding on the tenderers. No claim on this account shall be entertained.

3.0 Minimum eligibility criteria

The minimum eligibility criteria for award of the contract shall include the following:-

- 3.1 The Tenderer should be in a position to supply in specific delivery period at least 25% of the total quantity of the material for which the bid has been issued.
- 3.2 The Tenderer must submit documentary evidence in support of 3.1 in the form of certified copy of work order/payment certificate/vouchers for which the payment has been made.
- 3.3 The intending Tenderer must have experience in supply of similar materials having completed successfully during last 3 (Three) years ending March 2015 with supporting evidence/certified copy of bill for supply of materials and should be either of the following:
 - i) Three complete works for supply of similar materials each costing not less than the amount equal to 40% of the estimated cost i.e Rs.184515.00 only.
 - ii) Two complete works for supply of similar materials each costing not less than the amount equal to 50% of the estimated cost i.e Rs230644.00only.
 - iii) One complete work for supply of similar materials costing not less than the amount equal to 80% of the estimated cost i.e Rs. 369030.00 only.
 - iv) Average annual turnover for supply of similar material during the last three years ending 31st March"15 should be at least 30% of the estimated cost ie Rs138386.00 only.

- 3.4 In addition, the bidder has to submit the following:

3.4.1 Photocopy of Permanent Account Number Card (PAN).

3.4.2 Photocopy of TIN/Sales tax Registration Certificate.

3.4.3 An affidavit on judicial stamp paper (Format enclosed as Annexure – II) that all the Documents/information submitted by them are correct and they do not have any relationship with any CMPDI employee.

4.0 Submission of Offer

Tenderers are required to submit their offers in a single sealed envelope giving reference to the Tender Notice No. and date. The single sealed envelope shall contain offers in separate two envelopes properly sealed and superscribed as Envelope - I and Envelope - II respectively. Both envelopes as well as the single envelope containing the two envelopes must be sealed & secured. Envelopes sealed only by gum or stapled shall not be accepted.

The tenderers should sign with seal on all pages of tender document including all enclosures submitted with the tender. Offers received without signature and seal on all pages shall be rejected.

Two envelopes should contain the details of the offer as follows:

7. The lowest bidder will be decided on the basis of lowest bids against individual items.
8. The Tenderers should sign with seal on all pages of Tender Document including all enclosures submitted with the Tender. Offers received without signature and seal on all pages shall be rejected.
9. 100% payment will be made within 30 days after satisfactory supply, inspection & acceptance of the supplied materials against each supply order on submission of bill(s).
10. The offer must be valid for four months from the date of opening of the Tender(i.e Envelope II Price bid).
11. The successful Tenderer will be required to Deposit Security money amounting to 10% of the awarded value (value arrived based on the estimated annual consumption and item- wise finalized rates of successful Tenderer) in the form of Bank Draft (in favour of "**CMPDI Ltd., Regional Institute, Singrauli**" on any Nationalized Bank Payable at Jayant/Dudhichua/Morwa) within 15 days from the date of issuing order. EMD deposited by the tenderer will be converted to Security money which will be refunded to the tenderer within 30 days of satisfactory execution of the contract period.
12. The EMD will be refunded to the unsuccessful tenderers immediately after finalization of the Tender.
13. In case the Tenderer fails to Deposit Security money within the stipulated period the order shall be cancelled and the EMD Deposited against the Tender shall be forfeited.
14. Security Deposit will be forfeited in case of contractual failure.
15. In case of late supply by the supplier –
 - i) Penalty @ 0.5% per week or part thereof subject to a maximum of 10% shall be imposed.
 - ii) However in case of emergency, if the ordered materials are not supplied, within scheduled time period of 4 weeks, the Supply Order will be cancelled and materials shall be procured in full & part by CMPDI from other sources, and excess cost, if any, shall be recovered from the EMD/pending bills of the defaulting supplier.

The bidder should understand that any breach of this clause would constitute a serious offence for which appropriate legal action may be taken to ensure the enforcement of confidentiality clause.
