General terms & conditions are as under:-

- 1) Parties shall submit:
 - (a) VAT Regn. No (Photocopy of certificate) duly signed
 - (b) PAN No (Photocopy of certificate) duly signed
- 2) A copy of work order for similar nature of work or work completion certificate for similar nature of job in any Pvt. /Govt. Deptt.
- 3) Inspection: Date of Inspection should be intimated as soon as the fabrication job is completed. Supervision shall, however, be done by representative of OIC Pragati at your workshop during repair or after completion of the fabrication of job. There will be no compromise with regard to quality of works.
- 4) Delivery: Water Tank should be delivered in one & half month from the date of receipt of Work Order and within 4 days after final inspection at your workshop.
- 5) Guarantee: Warranty shall stand for six months from the date of delivery. Any defects in workmanship / materials will have to be rectified free of cost during guarantee period.
- 6) EMD: - Rs. 170.00 (one hundred seventy only). Same is to be deposited in the form of cash at cash section of CMPDI, RI-I Asansol during the office time. Bidders are requested to enclose cash Receipt of EMD along with the offer. No tender will be accepted unless accompanied by requisite EARNEST MONEY. The earnest money will not carry interest. The earnest money of unsuccessful bidder will be returned after finalization of tender on application.

- 7) Security Deposit: Successful bidder shall deposit 10% of the awarded value as security deposit after adjusting EMD amount. The same will be refunded after 3 months period on certification by OIC Pragati Exploration Camp that no rectification job is necessary.
- 8) Penalty: Delivery of water tank should be as per scheduled date as specified in work order. Penalty shall be imposed as 0.5% of the awarded value for each week of delay or part thereof subject to a ceiling of 10% of contract value after placement of firm workorder.
- 9) Payment: The payment shall be made by Finance Deptt. of CMPDI, RI-I Asansol against bill/challan in triplicate duly certified by OIC/Camp Pragati. Parties shall submit zerox copy of service tax certificate, if applicable.
