2 **Mode & Method of Submission of Tenders**

Tender must be submitted in sealed main envelope cover containing two separate sealed covers Part-I and Part- II. On the main envelope cover, the tenderer must be scribed with the Tender name, Tender enquiry number and the date of opening at top of envelope and tenderer name & address at bottom left of envelope. All envelopes containing the tenders shall be properly sealed.

The Tender is to be submitted in two parts viz. Part – I and Part –II in separate sealed envelope super scribed by part –I and Part –II

Part- I : Consisting of technical offer and commercial Terms & Conditions, along with Demand Draft towards Tender documents and certificate of down loading as per Annexure –VI should be included in the Part – I.

Bids Tender without Demand Draft towards Tender documents and certificate of down loading as per Annexure –VI, will be out rightly rejected.

Part- II: The second part of the tender shall consist of details of Prices only. The price bids of only those tenderers whose offer in Part –I is found to be techno – commercially acceptable will be opened.

3. **Validity Period of Tenders:**

The rates, terms and conditions offered shall be valid for a period of 120 days from the date of opening of the tender.

6. **SPECIAL TERMS AND CONDITIONS**

- (a) The prices quoted must be firm till delivery. The prices offered should be given preferably both in words and figures.
- (b) Printed terms and conditions of the vendor shall not be considered. Tenderers are requested to submit their offer complete in all respects maintaining serial number of items, terms and conditions as per the tender documents along with all supporting documents failing which offer may not be considered and no further clarification on technical commercial aspects may be entertained.
- (c) Delivery periods shall be within 30 days from the date of supply order in single lot.
- (d) Payment terms are as per general conditions of contract and are enclosed with this tender notice.
- (e) Supply Order, if placed, will be subject to the terms and conditions given separately. Chemicals / Additives

- (f) Participating bidder must possess self-attested copies of order experience of successful supply of minimum order of 50 % of quoted quantities for similar items (i.e. Chemicals / Additives as per Annexure –I of NIT) in any of last two financial years from subsidiaries of CIL/ any Govt. Organisations /PSU

List of past supplies with the details of order reference and the performance report, if any, should be furnished along with the Part -I bid

- (g) Normally no deviation is acceptable to our tender documents & Terms and Conditions. Tenders which have deviations are liable for rejection without making any back reference to the tenderers. Tenders asked for must be submitted complete in all respects for proof of above 6(f)
- (h) All disputes are subject to Bilaspur (CG) Court Jurisdiction only.

7. GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF OFFERS

- (a) The complete offer should be typed/hand written on the letter head of the tenderers. If firm's letter heads are not sufficient to accommodate technical and pricing details, preferably bigger papers should be used, such sheets along with other pages of the offer should be signed and stamped by company's authorized representative/official.
- (b) **All pages of tender documents should be signed and must have company's seal. This is a must.**
- © Quotations, erased and over written, will be summarily rejected unless corrections are authenticated with the tenderer's signature.
- (d) CMPDI reserves the right to reject or accept or withdraw the tender in full or part as the case may be without assigning reason thereof. Tenderers are advised to carefully note that the deviation in these terms will not be entertained.
