6. (a) The prices quoted must be firm till delivery. The prices offered should be given preferably both in words and figures.

- a. The complete offer should be typed/hand written on the letter head of the tenderers. - b. Quotations, erased and over written, will be summarily rejected unless corrections are authenticated with the tenderer's signature.
