Sealed quotations are invited for Supply & Installation of 3(three) nos of Water Purifiers as indicated in the attached schedule of requirement in Annexure-I.

1. Tender document shall be available in the office of the HOD(E&M), CMPDI, Regional Institute-III. Gondwana Place, Kanke Road, Ranchi-834008 Jharkhand or can be downloaded from CMPDI Website WWW.cmpdi.co.in from 06.01.2016 to 18.01.2016
2. **Tenders are to be submitted at the following address:**

3. **Date and time for submission of tender: up to 03.00 PM on 18.01.2016.**
4. **Date and time for opening of tender: 03.30 PM on 18.01.2016**
5. Tenders will be opened, before the attending tenderers or their authorized representatives who may wish to be present, in the office of the HOD(E&M), CMPDI, RI-3..
6. **General Instruction for submission of tender.**
Tender must be submitted, in sealed cover super-scribed with Tender number and due date of tender.
7. The rate shall be quoted on FOR destination i.e. RI-III, Store, CMPDI, Gondwana Place, Kanke Road, Ranchi-834008.
8. The prices quoted must be firm till delivery and the offer made, must remain open for acceptance for one month from the date of opening of tender.
9. Tender erased and over-written may be summarily rejected unless corrections are authenticated with the tenderer's signature. Over-writing should be avoided.
10. **Consignee** – Regional Director, RI –III, CMPDI, CMPDI, Gondwana Place, Kanke Road, Ranchi – 834008 (Jharkhand).
11. Materials are subject to final inspection at Consignee's end by an authorized representative of the Consignee.
12. The packaging of all the materials quoted shall conform to the requirements of the carrier.
13. Supply order, if placed will be subject to the Terms & Conditions of CMPDI/CIL.
14. The tenderer should enclose the brochure with specification of the items quoted by them.
15. **Warranty-**
The item should carry manufacturer's warranty for a period of not less than 12 months from the date of installation or 15 months from the date of supply whichever is earlier, against manufacturing defects.
16. **Delivery:**
a) Tenderers are to supply the quantity and items offered within a period of **30(Thirty)** days from the date of receipt of Supply Order.
b) Defective material, if any, will have to be replaced with fresh supply, by the supplier immediately, without causing any extra cost to CMPDI, RI-III.
17. **Installation:**
Water Purifier will be installed by the supplier at (a) Hazaribagh Sub-camp at Rohini (b) Barkakana Sub-camp at Balumath and (c) Orla Sub-camp at DVC Bermo

18. In the event of failure to supply within the stipulated date/period in accordance with the samples and/or specifications mentioned in the Supply Order and in the event of breach of any of the terms and conditions mentioned in the Supply Order, CMPDI, RI-III, has the right:

- a) To recover from the successful tenderer, as liquidated damages a sum not less than 0.5% (half percent) of the price of any stores which the successful tenderer has not been able to supply as aforesaid for each week or part of a week during which the delivery of such material may be in arrears, limited to 10% (ten percent). However where felt necessary, the limit of 10% can be increased to 15% at the discretion of the competent authority of RI-III, CMPDI, Ranchi.
 - b) To purchase elsewhere, after due notice to the successful tenderer, on the account and at the risk of defaulting tenderer the material not supplied or others of a similar description without cancelling the supply order in respect of the consignment not yet due for supply, or-
 - c) To cancel the supply order or a portion thereof, and if so desired, to purchase the material at the risk and cost of the defaulting supplier and also –
 - d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed Liquidated Damages referred to in Clause (a) above.
 - e) Whenever under the contract, a sum of money is recoverable from and payable by the supplier, CMPDI RI-III shall be entitled to recover such sum by appropriating in part or in whole, by deducting any sum or which at any time thereafter may become due to the successful tenderer in this or any other contract and should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay CMPDI RI-III on demand the remaining balance. The supplier shall not be entitled to any gain on any such purchase.
19. If the execution of the contract/supply order is delayed beyond the period stipulated in the contract/supply order as a result of outbreak of hostilities, declaration of an embargo or blockade, or fire, flood, acts of nature or any other contingency beyond the supplier's control, due to act of God, then CMPDI RI-III may allow such additional time by extending the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by CMPDI RI- III, the contract/supply order shall be read and understood as if it had contained from its inception the delivery date as extended.
20. **Payment :**
- (i) 100% payment will be made within 21 days after the date of installation of water purifiers at the specified locations or within 21days from the date of receipt of supplier's bill whichever is later.
 - (ii) **Paying Authority:**
HOD(Finance), CMPDI, RI-3, Gondwana Place, Kanke Road, Ranchi – 834008
21. CMPDI, RI-III does not bind itself to accept the lowest offer or any tender, and reserves to itself the right of accepting/rejecting (without assigning any reason thereof) whole or any part of the tender or portion of the quantity offered , and the tenderer shall supply the same at the rates quoted by them.
22. Offers received after the submission time of the due date of the tender, shall not be accepted.
23. CMPDI, RI-III shall not be responsible for non-receipt /delayed receipt of Tender Document.
24. All disputes are subject to the Court of Ranchi jurisdiction only.
