Last date of submission of offer will be **03-June-2016 up to 01:00 PM**.

2. Sealed quotation shall be opened on **03-June-16** at **03.30PM** in presence of the bidders or their authorised representatives . Authorized Representative must produce a power of attorney in his favour.
3. The offer shall be accompanied with the copies of :-
