TENDER DOCUMENT FOR OBTAINING COMPETITIVE RATES FOR PROVIDING EMERGENCY POWER SUPPLY AT PRAGATI DRILLING CAMP, CMPDI, RI-I.

TERMS AND CONDITIONS

1.	Rate is inclusive of all costs like supply of hardware, Installation, Maintenance, HSD, Lubricants and Security etc.
2.	The power-line should supply a continuous load of minimum 1560 watts so that all the lights glow together properly without any tripping/ disturbance.
3	In case of failure to provide power supply due to any reason, alternate arrangement shall be made immediately, failing which deduction of penalty charges at double the rate of accepted daily charges shall be made from bill. In case of part power supply, payment will be made on the basis of proportionate rate per point /per night. In case the owner fails to provide power supply for a continuous period of 15 days, the contract shall stand terminated automatically from the 16 th day. In such case, the penal charges shall be deducted as per the rate mentioned above from the pending bills, if any, and from the security deposit so deposited shall be forfeited.
4.	The management does not bear any responsibility whatsoever for repair, maintenance etc. of the power supply arrangement. The security of the hardware will be the responsibility of the owner himself. The owner has to repair/ make good/ compensate any expenses related to the operation of the power-supply arrangement.
5.	CMPDI management does not bind themselves to engage the services for providing power-supply throughout the month/period of work order. Expected duration of power supply would be at night i.e. 5.00 pm to 5.00 am for the year. No claim regarding increase of rate/change of any terms and conditions would be entertained during the period of work order.
6.	No advance payment will be made by CMPDI. Payment for providing water will be made on monthly basis through A/c Payee Cheque against pre-receipted bill raised by the party and duly certified by the Officer-in-Charge of the Camp.
7.	CMPDI, RI-I management also reserves the right to terminate/foreclose the contract on 15 days notice to the owner without assigning any reasons, whatsoever.
8.	The contract, if required, may be extended on the same rates, terms and conditions for next one year on satisfactory performance during the contract period.
9.	Security deposit shall be 10% of awarded value of the job for the contract period. EMD shall be adjusted against security deposit. Recovery of balance security deposit after adjusting the EMD will be made from the first 3-monthly bills. Total security deposit will be refunded on successful completion of the work. The security deposit shall carry no interest.
10.	Income Tax will be deducted as per rules. Bidders are required to submit copy of the income tax PAN and personal mobile no. along with the offer.
11.	The Management reserves the right to accept or reject any or all the offers without assigning any reason whatsoever.
12.	1)Service Tax Registration no. is required to be submitted by the Tenderers. Prima facie, it is their responsibility to deposit service tax on the applicable value of services and can be claimed/ reimbursed on submission of valid documents like challan copy etc. 2) For those tenderers, who are exempted from the service tax registration, shall have to submit an affidavit in that regard mentioning that their income for the present FY (2016-17) as well as, previous FY (2015-16) does not exceed Rs. 9,00,000/- (Rupees Nine Lakhs).
13.	The tenderer will indemnify the CMPDI from all claims for injuries caused to any person whether a workman or not, while in or upon the works or the site of the same and the CMPDI shall not be bound to defend any claim brought under the Workmen Compensation Act. Neither the CMPDI management will be held responsible towards any dispute in this respect.
