1. Rates should be inclusive of all taxes except service tax, duties, i.e. net price.
2. The offer must be valid for Two months time from the date of opening of tender
3. The repairing shall be completed within 15 days of the receipt of the work order
4. 90% payment will be released after satisfactory completion of work. Rest 10% will be kept as security deposit & will be released after expiry of six month from the date of handing over the fans.
5. In case of delay in repairing, a penalty @ 0.5% per week or part thereof subject to a maximum of 10% shall be imposed.
6. Tenderers shall sign all the pages- of the tender document before submission of the tender.
7. The rate contract will be for a period of one year from the date of entering into R/C at the agreed rate of each item and will remain firm throughout the contract period.
8. Management reserves the right to terminate the contract without assigning any reason with prior notice of one month.
9. Management reserves the right to have parallel R/C simultaneously with more than one party.
10. Management reserves its right to accept or reject any offer without assigning any reason whatsoever.
11. Repaired ceiling/exhaust fans should be guaranteed for the six months.

12. Non-disclosure/Confidentially Clause: The bidder will not at any time during pendency of contract or afterwards disclose to any person any information as to documents, components, parts, information, drawing, data ,sketches, plans, programs, specifications, techniques, process ,software, inventions and other material, both written and oral, of a secret, confidential or proprietary nature, including without limitation any and all information relating to finance, invention, research, design or development of information system and any supportive or incidental subsystem and any and all subject matter claimed in or disclosed by any patent application prepared or filled by or on behalf of CMPDIL, in any jurisdiction, and any amendments or supplements thereto. The bidder should understand that any breach of this clause would constitute a serious offence for which appropriate legal action may be taken to ensure the enforcement of confidentiality clause.

CMPDIL also desires that the bidder shall hold in trust and confidence, and not disclose to others or use for its own benefit or for the benefit of other, any Proprietary Information which is disclosed to the bidder by CMPDIL at any time during the agreement /award of work/execution of work and thereafter.
