TERMS & CONDITIONS:

1. Quotation document will be available in the office of H.O.D.(E&M), CMPDI, RI-IV, Nagpur - 440014 during working hours or can be downloaded from the CMPDI Website www.cmpdi.co.in from 10.10.2016 to 25.10.2016 .
2. Quotation can be sent by post or deposited in the Tender Box kept at the office of H.O.D. (E&M), CMDPI,RI-IV.
3. The Quotation sent by post must shall reach this office on or before 3 PM on 26.10.2016 or deposited in the Tender Box upto 3.00 PM on 26.10.2016.
4. The quotations will be opened at 3.30 PM on 26.10.2016 in presence of attending bidders or their authorized representatives in the office of HOD (E&M), CMPDI, RI-IV, Nagpur.
5. Offers received after the due date of submission for any reason whatsoever will not be accepted.
6. The bidder must have PAN and Sales Tax/VAT registration.
7. Quotation shall be submitted in sealed cover superscribing Quotation No. , Quotation for, due date of opening and name/seal of bidder.
8. The rate shall be quoted on FOR destination basis i.e., CMPDI, Jaripatka, Nagpur – 440014 and shall be inclusive of all applicable taxes, duties etc.
9. The price quoted must be firm till delivery and the offer shall be valid for three months from the date of opening of quotation.
10. Quotation erased or over-written may be summarily rejected, unless corrections are authenticated with the bidder's signature. Over-writing should be avoided.
11. Materials will be accepted subject to final inspection at our site.
12. Warranty: The energy meters should be covered by Manufacturer's Warranty for not less than one year from the date of supply. Warranty certificate must be given at the time of delivery of meters.
13. The supplier shall be the responsible for arranging replacement/rectification of any defect arising in the meters during the warranty period.
14. Delivery: The materials must be delivered within a period of 5-6 weeks from the date of issue of supply order.
15. The bidder must mention the make, type/model of offered energy meters.

16. Sample should be given, if required before final delivery of meters.
17. In the event of failure to supply the materials within the stipulated date, the company will be at liberty to cancel the order.
18. Payment: 100% payment will be made within 21 days after submission of bills in triplicate and its acceptance by H.O.D.(E&M).
