TERMS AND CONDITIONS

1.	The contractor shall supply 9 (nine) bhars of water to employees residing at Pragati Exploration Camp. Each bhar comprises 32 litres of water.
2.	The water shall be carried by the contractor in clean and hygienic buckets from the storage tank situated inside the camp premises. The condition of the buckets and their cleanliness will be periodically checked by OIC, Pragati Camp or his representative. The defective buckets are to be replaced immediately by new buckets.
3.	The number of bhars of water to be supplied by the contractor to camp inmates may vary as per the requirement. Bill to be claimed on the actual number of bhars supplied.
4.	The contractor shall supply water every day during the contractual period. In case of failure due to any reason beyond his control, he shall make alternate arrangements at his own cost failing which deduction of penalty charges at double the amount of daily average bill will be made from the monthly bill.
5.	Any dispute over the supply of water between the contractor and the camp inmates shall be settled by the OIC, Pragati Camp and his decision will be final.
6.	Any dispute between the contractor and the camp authority may be referred to the GM (Geology), RI-1, Asansol and his decision will be final.
7.	CMPDI, RI-I management also reserves the right to terminate/foreclose the contract on 15 days notice to the contractor without assigning any reasons, whatsoever.
8.	The management does not bind themselves to engage the services for the entire period of the work order. This period may be increased/ decreased as per the requirement of CMPDI. On expiry of the 1 st year, the contract is likely to be extended for another year on satisfactory performance during the 1 st year. No claim regarding increase of rate/change of any terms and conditions will be entertained during the period or extended period of the contract.
9.	No advance payment will be made by CMPDI. Payment towards distribution of domestic/drinking water will be made on monthly basis through A/c payee cheque against pre-receipted bill raised by the party and duly certified by OIC, Pragati Camp.
10.	Security deposit shall be 10% of awarded value of the job for the contract period. The EMD will be retained as initial security-deposit. EMD shall be adjusted against security deposit. Recovery of balance security deposit after adjusting the EMD will be made from the first 3-monthly bills. Total security deposit will be refunded on successful completion of the work. The security deposit shall carry no interest.
11.	<p><u>Wages & workmen compensation: :</u></p> <p>i) The Contractor should ensure that payment of wages to the workers to be engaged by him should not be less than the minimum wages, as notified by the Ministry of Labour, Govt. of India from time to time as applicable to the area in which the workers will be engaged.</p> <p>ii) The contractor/contractors shall make necessary payments of Provident Fund for the workmen employed by him/them for the work as per the terms prevailing under provisions of CMPF/EPF and allied scheme.</p> <p>iii) The contractor will ensure that all workers employed by him get one day off per week. If the worker/workers has/have to work on all seven days of the week, he/they shall be paid double wage for the seventh day.</p> <p>iv) The tenderer will obtain "Workmen's Compensation Insurance" to all the persons employed by them as per statutory rule.</p> <p>v) The tenderer will indemnify the CMPDI from all claims for injuries caused to any person whether a workman or not, while in or upon the works or the site of the same and the CMPDI shall not be bound to defend any claim brought under the Workmen Compensation Act. Neither the CMPDI management will be held responsible towards any dispute in this respect.</p>
12.	The Management reserves the right to accept or reject any or all the offers without assigning any reason whatsoever.
13.	1) Service Tax Registration no. is required to be submitted by the Tenderers. Prima facie, it is their responsibility to deposit service tax on the applicable value of services and can be claimed/ reimbursed on submission of valid documents like challan copy etc.

	2) For those tenderers, who are exempted from the service tax registration, shall have to submit an affidavit in that regard mentioning that their income for the present FY (2016-17) as well as, previous FY (2015-16) does not exceed Rs. 9,00,000/- (Rupees Nine Lakhs).
14.	<p><u>Claiming of Bills:</u></p> <p>i) The contractor, if not already registered, after receiving the work-order for the above job shall apply to the Regional Commissioner, CMPF, Region III, B B College Road, Ushagram, Asansol-3 for registration of contractors under CMPF through the Regional Director, RI-1, Asansol.</p> <p>ii) While claiming of the bill the contractor shall have to enclose the copy of the payment register showing the names of the workers, category of workers, number of working days per month, signature of the worker employed by him and the wages paid to them, duly certified by the OIC, Pragati Exploration Camp.</p> <p>iii) The claimed bill shall be paid after deduction of admissible CMPF/EPF for each workmen deployed by the contractor.</p> <p>The above deducted CMPF/EPF shall be deposited in the CMPF/EPF account of the concerned worker.</p>
15.	In case of failure to provide satisfactory services, the security deposit is liable to be forfeited, in addition to penal charges, if deemed fit by the management.
16.	Bidders are required to submit self-attested photocopies of the PAN card for along with the offer.
17.	Income Tax will be deducted as per rule.
