

**NOTICE INVITING TENDER FOR HIRING OF ONE NUMBER WATER TANKER MOUNTED TRUCK FOR DEPLOYMENT AT

Sealed offers are invited in the prescribed document from the reputed agencies/firms/individuals for deployment of One number water tanker mounted truck on hire basis for hauling of drilling water for CMPDI, RI-I drilling site, Itapara, dist - Burdwan. Tender details for the job are given below.

1. Tender No. & date	: CMPDI/RI-I/Expln/Tanker Mounted Truck/Pragati /16-17/ 577 Date: 29/12/16
2. Job Description	: Deployment of one number water tanker mounted truck of 10,000 ltrs. capacity approximately for hauling of drinking as well as domestic water at CMPDI, RI-I Itapara drilling site from 6.00 AM to 6.00 PM per day for a period of 60 working day from the award of work. Diesel & Mobil will be supplied by camp Pragati CMPDI, RI-I.
3. Tenure of hiring	: 60 working day from the award of the work.
4. Details of Vehicle & Driver	: Truck should have water tanker mounted on it having capacity 10,000 ltrs approximately. It should be in good running condition and Road worthy having valid Road Tax, Insurance, Fitness, Pollution certificates etc. Photo copies of Vehicle Registration and all other certificates duly signed by the tenderers are to be submitted. In case same rates were offered by the parties, preference will be given to the party having latest model vehicle i.e. tanker mounted truck. Driver of the vehicle must have valid driving license and at any point of time, he should not be under the influence of drinks or drugs while on duty.
5. Cost of tender document	: Rs. 100/- (Rupees one hundred) only.
6. Earnest Money Deposit	: Rs. 840/- (Rupees eight hundred forty) only has to be deposited in cash or in the form of a Crossed Demand Draft drawn in favor of " CMPDI, Regional Institute, Asansol " on any scheduled Bank payable at Asansol.



GENERAL TERMS AND CONDITIONS:

1	Sealed offers are invited from the reputed agencies/firms/individuals for deployment of one number tanker mounted truck on hire basis for hauling of drilling water at CMPDI, RI-I exploration camps, from 6.00 AM to 6.00 PM per day for a period of 2 months (60 working days) from the date of award of the work.
2	<p>The tender document shall be submitted in two parts by the renderer in separate sealed envelopes. Full name and address of the renderer shall be written on the bottom left hand corner of all the sealed envelopes. Tender No. And name of the work "Hiring of vehicle" date and time of opening shall be indicated on the right hand corner of the envelop. The tenders shall be dropped in the Tender box kept in the Office of the G.M. (Geology).</p> <p>In Part-I-Technical parameters, commercial terms and conditions, proof of EMD payment (receipt of payment or Demand Draft,) proof of payment of application fees (receipt of payment or Demand Draft),copy of PAN card, relevant papers of R.T.O relating to ownership of the vehicle Registration ,Road Tax, Insurance , Fitness certificate etc. Agreement on non-judicial stamp-paper with owner of the vehicle (for vehicle not owned by the vehicle provider) and shall be kept in one envelope and should be written as Part-I .The Tenderer or his authorized representative will sign all the pages of the Tender document as confirmation of acceptance of all the terms and conditions and submit the same along with Part-I of the offer. All the documents shall be self-attested. Cost of tender document and earnest money deposit is essential in case of bidder who have downloaded the tender document failing which their Part-II offer will not be entertained.</p> <p>In Part-II Price bid to be kept in separate envelope written as part-II .Both the envelopes i.e. Part-I and Part-II shall be kept in an outer envelope super scribing the name of the work, Tender No. & full address, telephone number etc. of the Tenderer.</p>
3	In case of any corrections/overwriting in the offer, the person signing the offer shall authenticate it.
4	CMPDIL management does not bind itself to accept the lowest tender and reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
5	CMPDIL management reserves the right to terminate/foreclose the contract on 15 days' notice to the party (successful bidder) without assigning any reason whatsoever.
6	Full information regarding tenderer such as full name, postal address, PAN number, service tax registration number (if applicable) and phone number are required to be furnished.
7	The party/agency shall submit the offer in the format prescribed and signed copy of the terms & conditions as a token of acceptance of NIT terms and conditions.
8	Log book is required to be maintained indicating the distance traveled in km., and issue of fuel and engine oil with date, quantity, speedometer reading etc. Speedometer should always be on running condition.
9	Driver shall have valid driving license for driving Truck/Heavy vehicle. In case of break-down of the vehicle or problem with the driver, the contractor/owner of the vehicle shall arrange a replacement vehicle/driver immediately and shall have to submit all requisite papers/documents pertaining to the replacement vehicle.
10	The contractor/contractors should ensure that payment of wages to the workers to be engaged by him is not below the minimum wages, <u>as notified by the Ministry of Labor, Govt. of India</u> from time to time as applicable to the area
11	The contractor /contractors shall make necessary payments of provident Fund for the work man employed by him/them for the work as per the terms prevailing under provisions of CMPF and allied scheme of miscellaneous provisions act 1948 or employees provident fund act and miscellaneous provisions act 1952 as the case may be.
12	Contractor is governed by workman's compensation Act. They can also obtain Life Insurance in the name of workers employed by them to protect any injury of fatal incident.
13	The tenderer will indemnify the CMPDI from all claims for injuries caused to any person whether a workman of not, while in or upon the works of the site of the same and the CMPDI shall not be bound to defend any claim brought under the Workmen Compensation Act. Neither the CMPDI management will be held responsible towards any dispute in respect of the vehicle engaged on hiring. .
14	Tender shall have to submit P.F. Registration No. those who have no P.F. Reg. No. shall submit their offer only after enrolling for P.F. Reg.at P.F. Office.

15	Earnest Money Deposit :	No tender will be accepted unless accompanied by requisite Earnest Money. The earnest money will not carry interest. The earnest money of the unsuccessful bidders will be returned after the finalization of the bid on request from the party. EMD of successful bidder will be refunded after satisfactory completion of work.
16	Category	Commercial /Private (If Pvt. The same is require to be converted into commercial within 15 days from the date of issue of the work order)
17	Opening of offers :	Offers will be opened on due date and time at the place specified in NIT in the presence of attending tenderers or their authorized representatives. L-I party will be decided on the basis of hiring charges per day only. If two parties quote the same rates L-I party shall be decided in the basis of higher model of the vehicle

COMMERCIAL TERMS AND CONDITIONS:

1	Paying authority :	HOD (Finance), CMPDI, RI-I, Asansol.
2	Payment terms	Payment will be made on submission of required documents and bills, duly certified by the O.I.C. Pragati camp/ .Payment will be made through Account payee Cheque.
3	Tax deduction at source:	The income tax will be deducted at source as per the applicable rules and a certificate will be issued at the end of the year unless the Bidder produces an exemption certificate from Income Tax authorities.
4	Service Tax	Service Tax registration number, is to be provided for reimbursement of claim. If exempted from service tax payment, proof/reason Affidavit by the Notary has to be submitted on non-judicial stamp paper of Rs.10/-
5	Hiring charges :	CMPDIL management does not bear any responsibility for maintenance/repair charges, tyres, tubes, flaps, and wages for drivers, gear oil, brake oil, coolant, grease, distilled water, road tax, insurance, PUC charges, fitness fees, any other taxes and levies etc. Hiring charges shall be on per day basis. Diesel/lubricant will be supplied by CMPDI at the rate of 1 (one) liter of HSD for every 03 Km. run and mobile at the rate of 1 liter for every 200 Km. run.
6	Penalties :	The charges against fuel consumption in short of 3 km/liter will be deducted from the monthly bills.
7	Security Deposit:	Security deposit shall be 10% of total value of the awarded value for providing service of vehicle for the contract period. The EMD shall be retained as initial security deposit which will be adjusted against total security deposit. The balance security deposit will be deducted from the first monthly bill. The security deposit shall carry no interest and shall be refunded after successful completion of the work.
