2. The bidder shall have past experience in servicing and repairing of such machines in reputed organization under maintenance contract.
3. The bidder has to provide comprehensive annual maintenance (preventive and corrective maintenance) of window & split type room air conditioners (1.5 Te.) of different make. The rate should be quoted per machine per year basis inclusive of the cost of repairing / replacement of all defective / unserviceable parts / spares including evaporator, condenser, compressor expansion valves, starting and running condensers, relays, thermostat switch, air filter, inside painting, gas charging, fan motor etc. and any part whatsoever needed due to any cause (free of cost), but **EXCLUSIVE OF COMPRESSOR, BODY, BASE AND FRONT PANEL REPAIRING AND REPLACEMENT**. 6. In the event of breakdown, the party has to ensure that the fault will be attended within 24 hours from the date / time intimated by CMPDI. Complaints will be communicated to the contractor over telephone / letter / email.

8. The contractor shall be responsible for keeping the Air Conditioners in maintained and perfect working conditions for one year from the time of placing the Work Order.
9. The service personnel, expert technician must attend the machines positively once in a calendar month for preventive maintenance / servicing & as and when called for. All defects occurring in the machines shall be immediately rectified during working hours at site as far as possible. On receipt of complaint the machine shall be attended to within 24 hours. Any violation of this clause will render performance unsatisfactory.
10. If repairing of the defective machines take more than one day, it must be replaced by free of cost loan service machines in place of the defective machine, immediately.
11. If the machines are required to be serviced / overhauled / major repairing by carrying it to the workshop, the same should be returned after repairing, within 10 days from the receipt of the same and the machine should be reinstalled at its original place. The to-and-fro carrying cost has to be borne by the party.
12. The contractor will be responsible for the damage or loss caused to the machine during handling and when the machine is in their custody.

29. Uptime Guarantee

The contractor should ensure 95% uptime of the machine. The uptime and downtime will be calculated on the basis of clause 30.

30. Downtime Penalty

- The Party provides guarantee 95% availability (uptime) for the machines on quarterly basis.
- Equipment downtime will be reckoned only during the working hours. Downtime beyond these hours on a working day would be excluded. For example, if the down time starts at 12.00 hours on a day and extends up to 11.00 hours the following working day, the down time would be calculated as below:
