The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending 31st January, 2018 should be either of the following :
 - i) Three similar completed works each costing not less than 40% of estimated cost or
 - ii) Two similar completed works each costing not less than 50% of estimated cost or
 - iii) Three similar completed work costing not less than 80% of estimated cost.
3. Photocopy of PAN (Permanent Income Tax Account No.), valid Electrical Licence, GST registration and credential for similar nature of work should be submitted along with BOQ. In case, not registered with GST then declaration will be required.
4. Contract period – Thirty (30) days from the date of issue of work order.
5. The overall lowest bidder shall be considered for award of the work. Being lowest in any part of the quotation shall be of no consequence and such bidders shall not have any claim for award of part work.
