The details of Terms & conditions are as under :-

1. Earnest money amounting to **Rs. 320.00 (Rupees three hundred twenty only)** is to be deposited in the form of Demand Draft drawn in favour of “CMPDI Ltd” on any Scheduled Bank payable at its Branch at Ranchi and should be submitted in a different envelope.
2. Photocopy of GSTIN. If not registered, then declaration for unregistered bidder.
3. Photocopy of PAN (Permanent Income Tax Account No.).
4. Full name & address of the tenderer shall be written on the bottom left hand corner of the sealed cover.
5. Bidders shall quote the rate of the items without the impact of GST. L1 will be decided on Cost to the Company basis.
6. Contract period – One year from the date of issue of work order.
7. The Earnest Money of the unsuccessful bidders shall be refunded after award of work and shall bear no interest.
8. No quotation will be accepted unless accompanied by requisite Earnest Money Deposit as stated above.
9. Controlling Authority: GM (TE & CM), CMPDI (HQ), Ranchi or his authorized representative.
10. Paying Authority: GM (F/EXP), CMPDI (HQ), Ranchi.
11. **Security Deposit :** Security deposit consist of two parts; a) Performance security to be submitted at award of work and (b) Retention money to be recovered from running bills. The security deposit shall bear no interest. The EMD shall be treated as part of security deposit balance amount against 5% of security deposit should be submitted within 28 days from issuance of LOA by the successful bidder in the form of Demand Draft in favour of “**CMPDI Ltd**” on any Scheduled Bank payable at its Branch at Ranchi.
