- Submission of Bill:** Pre-receipted tax invoice as per GST provisions in triplicate duly stamped to be submitted. Our GST No 22AAACC7475N1ZE is required to be incorporated in your tax invoice. The GST registered supplier shall upload their invoice in their GSTR-I before claiming their bills from CMPDI.

3. **Payment:** - 100% payment will be made within 21 days after submission of bill and acceptance.
4. **Paying authority:** HOD (Finance), Regional Institute-V, Bilaspur (CG).
5. **Consignee: Regional Director, CMPDI, RI-V, SECL Complex, Seepat Road, Bilaspur (CG).**
6. **Liquidated Damage:** - In case the work is not completed within the stipulated period, an LD of 0.5% per week and part thereof subject to a ceiling of 10% will be deducted from the bill.
7. **Taxes and Duties :**
 - i. **Goods and Service Tax (GST):** GST will be payable extra as per prevailing GST Rules. Bidders have to clearly indicate GST rates applicable (SGST, CGST, IGST) in Price Bid/BOQ.
 - ii. If the tenderer is exempted from buying from paying the GST or Bidder has opted for GST under Composition scheme, the same must also be confirmed with valid documentary evidence.
