IMPORTANT NOTE:-

Bidders are requested to submit the offer complete in all respects as per the tender document along with supporting documents, failing which the offer may not be considered.

All pages of the offer, including enclosures, should be signed and stamped without which the offer shall be rejected.

II. COMMERCIAL TERMS AND CONDITIONS: Bidders are requested to read the following terms and conditions carefully before submitting the offer. It is essential for the Bidder to unconditionally accept all the terms and conditions indicated below:

1. The tenderers shall quote as per the specifications given in the Schedule of Requirement as per Annexure-I.
2. The rates quoted should be firm, exclusive of GST and **GST should be quoted extra** and for CMPDI, RI-VII, Bhubaneswar and shall be valid for 01 year from the date of issue of work order. In case the party has not been registered the same should be mentioned clearly.
3. Transportation cost to and from the "Regional Environmental and Chemical Laboratory, Central Mine Planning & Design Institute Limited, Regional Institute-VII, Samantpuri, P.O: RRL, Bhubaneswar-751013 (Odisha)" should be borne by party.



4. A DD/Banker's cheque in favour of "CMPDI LTD, REGIONAL INSTITUTE, BHUBANESWAR" amounting to Rs 500.00 (Rupees five hundred only) shall be deposited by bidder towards EMD.
