2. Earnest money:

The Earnest Money is to be deposited in the form of Bank draft/demand draft from any Nationalised Bank drawn in favour of "CMPDI Limited, Regional Institute, Ranchi" payable at Ranchi only and its date of issuance should be on or after the date of issue of NIT. The earnest money/ Bid Security of the unsuccessful bidder shall be refundable as promptly as possible and shall bear no interest. No Bid will be accepted unless accompanied with requisite earnest Money deposit as stated above. The earnest money should be deposited in a separate envelope marked as earnest money.

3. Eligibility Criteria to qualify for the award of contract :-

a) Tender document should be duly signed in all the pages .

b) The intending tenderer must have in its name as a prime contractor, experience of having successfully completed similar works during last 7(seven) years, ending last day of the month previous to the one in which bid applications are invited,(i.e. eligibility period) should be any of the following-

Three similar completed work costing not less than the amount equal to 40% of the estimated cost put to tender.

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost put to tender.

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost put to tender.

In all the above cases, while considering the value of completed works, the full value of completed work will be considered whether or not the date of commencement is within the said seven years period.

In case the bidder is not a prime contractor but a sub-contractor, the bidder's experience as sub-contractor will be taken into account, against suitable document that the contract in support of qualification is a sub-contract in compliance with the provision of such sub-contract in the original contract awarded to prime contractor.

cj) Average annual financial turnover of Civil works during the last 3(three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost put to tender.

Financial turnover and cost of previous completed works shall be given a simple weightage of 5% per year (average annual rate of inflation) to bring them at current price level.

Availability of bid document.

Validity period of offer:-

The rate offered in Part-II should be valid for 120 days from the last date of submission of BID.

General Instruction for Submission of BID:-

Bidder is required to submit his offer in sealed cover giving reference to this Bid Notice no. and date containing offer in two envelopes as specified in the quotations document. All credentials documents, EMD and price bid should be in sealed covers super scribing name of the work, Bid Notice reference no. and Date of opening of the sealed Envelope. The bid will be opened on the date of opening of bid.

7. Following documents are required to be submitted with part -I of the quotation :-

- a) Firm registration details/ any other document of the firm.
- b) Power attorney in case the tender is signed by authorized representative of the tenderer.
- c) Photo copy of PAN card either of the firm or of the individual as the case may be.
- d) Credential of satisfactory performance of contracts completed with full details of clients location of work, cost and time taken for completion during the period as mentioned at serial no.3.
- e) An undertaking in the format enclosed with quotation document.
- f) Copy of Provident Fund Registration Certificate issued by Govt. Dept of any Indian State

(g) Goods and Service Tax (Not Applicable for Exempted Goods/Services): DOCUMENTS TO BE SUBMITTED:-

15. The tenderers are advised to see the relevant site and offer their rates in terms of percentage rate against the estimate.
