2. Earnest money:

The Earnest Money is to be deposited in the form of Bank draft/demand draft from any Nationalised Bank drawn in favour of "CMPDI Limited, Regional Institute, Ranchi" payable at Ranchi only and its date of issuance should be on or after the date of issue of NIT. The earnest money/ Bid Security of the unsuccessful bidder shall be refundable as promptly as possible and shall bear no interest. No Bid will be accepted unless accompanied with requisite earnest Money deposit as stated above. The earnest money should be deposited in a separate envelope marked as earnest money

3. Eligibility Criteria to qualify for the award of contract :

a) The intending tenderer must have in its name as a prime contractor, experience of having successfully completed similar works during last 7(seven) years, ending last day of the month previous to the one in which bid applications are invited,(i.e. eligibility period) should be any of the following-

Three similar completed work costing (including all taxes) not less than the amount equal to 40% of the estimated cost put to tender.

OR

Two similar completed works each costing (including all taxes) not less than the amount equal to 50% of the estimated cost put to tender.


OR

One similar completed work costing (including all taxes) not less than the amount equal to 80% of the estimated cost put to tender.

In all the above cases, while considering the value of completed works, the full value of completed work will be considered whether or not the date of commencement is within the said seven years period.

In case the bidder is not a prime contractor but a sub-contractor, the bidder's experience as sub-contractor will be taken into account, against suitable document that the contract in support of qualification is a sub-contract in compliance with the provision of such sub-contract in the original contract awarded to prime contractor.
