MAIN TERMS & CONDITIONS.

(A.)

1. Rate is inclusive of cost of water if any and all other operational cost involved in supply of water.
2. Water should be supplied continuously as per requirement between 6.00 am to 6.00pm properly without any disturbance.
3. In case of failure to supply water due to any reason, Alternate arrangement shall be made immediately, failing which deduction of penalty charges at double the rate of accepted daily rate shall be made from the bill. In case of part water supply on any day, payment will be made on prorata basis. In case the contractor fail to supply water for a continuous period of 15 days, the contract shall stand terminated automatically from the 16th day.
4. The management does not bear any responsibility whatsoever for security, repair, and maintenance etc. of supply pump used for supply of water.
5. CMPDI management does not bind itself to engage the services for supply of water throughout the month/ period of work order. No claim regarding increase of rate/ change of any terms and conditions would be entertained during the period of work order. However, the management reserves the right to change/ alter any of the terms of the contract.
6. No advance payment will be made by CMPDI. Payment for providing water would be made on monthly basis through NEFT against pre-receipted bill raised by the party and duly certified by the Officer- in charge of the camp.
7. CMPDI, RI-1 management also reserve the right to terminate /foreclose the contract on 15days notice without assigning any reasons, whatsoever.
