### NOTICE INVITING TENDER

Sealed quotations are invited from the AUTHORISED DEALER/DISTRIBUTER of RIDGE TOOLS COMPANY (RIDGID) for the supply of SPARES for RIDGID make Pipe Wrenches (as per specification given in Price Bid Format enclosed as Annexure – I) to CMPDI, RI- III, Ranchi.

2. Quotations are to be submitted in the office of:

4. Date and time for opening of tender: **3.30pm on 06/08/2020**
5. Tenders will be opened before the attending tenderers or their authorized representatives who may wish to be present.
6. **Earnest Money Deposit (EMD): Not required.**
7. **Cost of tender:- Nil**
8. **General Instruction for submission of tender:**
  - a) Tenderer is required to submit their offer in a sealed cover containing -  
(i) The complete Tender Document duly signed by the tenderer on all pages with proper seal.  
(ii) Price Bid Format as at Annexure –I, duly filled in and signed by the tenderer on all pages with their proper seal.  
(iii) Photocopy of PAN. (Permanent Account Number) and Registration with appropriate authority under GST mentioning GSTN, duly attested by the tenderer.  
(iv) Sealed cover must be super scribed with Tender Enquiry No; date of opening and name with address of the tenderer  
(v) Price Certificate as per Annexure-IV, Non-Banning/Delisting Certificate as per Annexure-III and e-Payment mandate form as per Annexure-II  
(vi) Photo copy of current authorisation certificate from OEM (RIDGE TOOLS COMPANY (RIDGID)) for authorised dealer/ distributorship in the name of the bidder should be submitted along with the offer.
9. The rate shall be quoted on FOR destination, RI-III Exploration Stores, CMPDI, Gondwana Place, Kanke Road, Ranchi
10. The prices quoted must be firm till delivery and the offer made must remain open for acceptance for six months from the date of opening of tender.
11. Quotations erased and over-written may be summarily rejected unless corrections are authenticated with the bidder's signature and seal. Over-writing should be avoided.
12. **Consignee – HOD (Expl.), RI –III, CMPDI, Gondwana Place, Kanke Road, Ranchi – 834008 (Jharkhand).**
13. Materials are subject to final inspection at Consignee's end by an authorized representative of the Consignee.
14. Supply order, if placed, will be subject to the Terms & Conditions of CMPDI/CIL.
15. **Security Money: There will be no security money.**
16. **Delivery:**
  - a) Tenderers are required to supply the materials within a period of 10 days, from the date of receipt of order(s), to the consignee.
  - b) Supplied material should accompany the (i) standard warranty/ guaranty certificate, (ii) lowest price certificate and (iii) fitment certificate with corresponding Ridgid products.
  - c) Defective material, if any, will have to be replaced with fresh supply by the supplier immediately, without causing any extra cost to CMPDI, RI-III.



17. **LD Clause**: In the event of failure to deliver the stores within the stipulated date/period mentioned in the Supply Order, CMPDIL, RI-III, has the right:

- To recover from the supplier, as liquidated damages, a sum not less than 0.5% (half percent) of the price of any stores which the supplier has not been able to supply for each week or part of a week, limited to 10% (ten percent).
- To purchase elsewhere, after due notice to the successful tenderer, at the risk and cost of defaulting supplier for the stores not supplied without cancelling the supply order, or-
- To cancel the supply order or a portion thereof, and also –
- To extend the period of delivery with or without L.D., as the case may be. The L.D., if imposed shall not be more than the agreed Liquidated Damages referred to in Clause (a) above.

18. If the execution of the contract/supply order is delayed beyond the period stipulated in the contract/supply order as a result of outbreak of hostilities, declaration of an embargo or blockade, or fire, flood, acts of nature or any other contingency beyond the supplier's control, due to act of God, then CMPDI RI-III may allow such additional time by extending the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by CMPDI RI-III, the contract/supply order shall be read and understood as if it had contained from its inception the delivery date as extended.

19. Payment :

- 100% payment will be made within 21 days from the date of receipt and acceptance of the materials by the Consignee through e-payment. Bidder should fill up enclosed e-mandate form as per Annexure-II and submit a crossed cheque.
- Paying Authority: HOD (Finance), CMPDI, Regional Institute-III, Gondwana Place, Kanke Road, Ranchi – 834008

20. Offers received after the submission time /date of the tender, shall not be accepted.


21. CMPDI, RI-III shall not be responsible for non-receipt /delayed receipt of Tender Document.

22. **Banned or Delisted suppliers**: Bidders should give a declaration on their letter head that they have not been banned or de-listed by any govt. or quasi-govt. or PSU. If a bidder has been banned by any govt. or quasi-govt. or PSU, this fact must be clearly stated and it may not necessarily be a cause for disqualification. If this declaration is not given, the bid will be rejected being non-responsive. A certificate in the format as per annexure-III on the letter head pad shall be enclosed on the letter head pad along with the quotation.

23. Right to Information act: Any document/information submitted by the bidder can be made public at appropriate stage, as per Right to Information Act 2005.

24. **PRICE FALL CLAUSE** - The price charged for the Stores / Equipment supplied against the order, if placed, shall in no event exceed the lowest price at which the Bidder sells or offers to sell the Stores / Equipment of identical description to any other Agency, including DGS&D, during the pendency of the Contract / Supply Order. If the successful Bidder at any time during the pendency of the Contract / Supply Order, sells or offers to sell, such stores to any other Agency, including DGS&D, at a price lower than the price stipulated in the Contract / Supply Order placed by CMPDI, the successful Bidder shall forthwith notify to CMPDI such reduction. The sale price of stores / equipment supplied after such reduction coming into force shall stand correspondingly reduced. A price certificate in the format as per annexure-IV on the letter head pad shall be enclosed on the letter head pad along with the Invoice.

25. All disputes are subject to the Court of Ranchi jurisdiction only.
