  - a) To recover from the supplier as Liquidated damages, a sum not less than 0.5% (half percent) of the price of any stores which the supplier has not been able to supply for each week or part week, limited to 10% (ten percent) of the ordered value.
  - b) To purchase elsewhere, after due notice to the successful tenderer, at the risk and cost of defaulting supplier for the stores not supplied without cancelling the supply order or
  - c) To cancel the supply order or a portion thereof and also –
  - d) To extend the period of delivery with or without L.D., as the case may be. The L.D., if imposed shall not be more than the agreed Liquidated Damages referred to in clause (a) above.
18. If the execution of the contract/ supply order is delayed beyond the period stipulated in the contract/ supply order as a result of outbreak of hostilities, declaration of an embargo or blockade or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God, then CMPDI RI-I may allow such additional time by extending the delivery period as it considers to be justified by the circumstances of the case and its decision shall be final.
