### Scope of Work:

- 1.1 Arranging 3 HP Submersible pump with minimum discharge head of 150m, good quality & working for pumping and drawing water from deep piezometers.
- 1.2 Arranging good quality & working DG / Gen Set of equivalent capacity to draw water using 3 HP pump having discharge head **150m**. Fuel cost for DG/ Genset to be borne by party.
- 1.3 Discharge Pipe Length- **200m** to be arranged.
- 1.4 Pumping Duration at each location- **2 hrs maximum**.
- 1.5 Arrangement of artificial lights (Equivalent to 2\*100 wattbulbs) and equivalent length (20 mtrs) connecting wire, electrical socket etc have to be done in case work extends beyond 6pm.
- 1.6 Adequate number of **workers (3-4)** along **with minimum one supervisor** should be available at site for the entire duration of the work. The supervisor should have adequate knowledge about pumps, DG/ Gen set and other electrical requirements for the site work and site setting.
