

- 10. The prices quoted must be firm till delivery of the refurbished rods to the destination.
11. Quotation erased and over-written may be summarily rejected unless corrections are authenticated with the bidder's signature and seal over-writing should be avoided.
12. **Consignee :** HOD (Geology), CMPDI, RI-I, GT road (west end), Asansol-713304 (W.B)
13. Materials are subject to final inspection at Consignee's end by an authorized representative of the Consignee.

14. Scope of NIT:

- a) Old/ unused rods should be collected from drilling camps of CMPDI RI-I, Asansol.
- b) One side box thread and one side pin thread on each end of the old rods.
- c) All the dimensions of thread must be complied with N size standard of Longyear.
- d) Rates are inclusive of both end thread and plastic cap and length of each rod must be 2.90m of 3.0m rods.
- e) Finishing of machined part must be done by CNC lathe.
- f) **Warranty/ Life:** Each rod should run minimum 1500m.

15. Supply Order, if placed will be subject to the terms & conditions of CMPDI/ CIL.

16. **Security Money:** There will be no security money.

17. Delivery:

- a) Tenderers are required to supply the materials within a period of 6 weeks from the date of receipt of order(s) to the consignee.
- b) Supplied material should accompany the (i) standard warranty/ guaranty certificate and (ii) fitment certificate.
- c) Defective material, if any will have to be refurbished again by the supplier immediately, without causing any extra cost to CMPDI, RI-I.

18. **LD Clause:-** In the event of failure to deliver the stores within stipulated date/period mentioned in the supply order CMPDIL, RI-I has the right:

- a) To recover from the supplier as Liquidated damages, a sum not less than 0.5% (half percent) of the price of any stores which the supplier has not been able to supply for each week or part week, limited to 10% (ten percent) of the ordered value.

If the execution of the contract/ supply order is delayed beyond the period stipulated in the contract/ supply order as a result of outbreak of hostilities, declaration of an embargo or blockade or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God, then CMPDI RI-I may allow such additional time by extending the delivery period as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by CMPDI RI-I, the contract/ supply order shall be read and understand as if it had contained from its inception the delivery date as extended.
