##### I. MODE & METHOD OF SUBMISSION OF TENDER: -

It is requested to submit the offer complete in all respects as per the tender document along with supporting documents, failing which the offer may not be considered.

##### II. COMMERCIAL TERMS AND CONDITIONS: Bidders are requested to read the following terms and conditions carefully before submitting the offer. **It is essential for the Bidder to un-conditionally accept all the terms and conditions indicated below:**

- 1) The tenderers shall quote as per the specifications given in the Schedule of Requirement as per Annexure-I.
- 2) The rates quoted should be firm, inclusive of GST and for CMPDI, RI-VII, Bhubaneswar and shall be valid throughout the period of the work.
- 3) The tender shall be opened on **31.12.2021 at 04:00 PM** in **REC Lab, Ground Floor, South Side, CMPDI, RI-VII, Bhubaneswar**. [If the tender is not opened on the above date due to unforeseen circumstances, then it will be opened on the next working day.]

- 5) All the tools, machinery and any other items required for calibration and AMC shall be arranged by the party.

8) Payment will be made in 3 equal installments after satisfactory completion of 01 (One) visit for every 4 months period.

9) 95% of bill amount will be paid to the party after every visit and the 5% will be deducted as retention money. The retention money will be released after successful completion of all 3 visits in 01 year.

10) Payment will be made after successful completion of every visit within 21 days from the date of receipt of invoice in triplicates raised to OIC (LAB), fulfilling all GST norms and duly accepted at REC LAB, CMPDI RI VII, Bhubaneswar.

11) The charges for AMC shall remain firm till the completion of the period of work order i.e 1 year from the date of issue of the work order for AMC.

12) The tax invoice raised must be in compliance of relevant GST Acts, rules & notifications made thereunder and should bear the GSTIN 21AAACC7475N1ZG.

13) Payment terms: The payment for each batch shall be made only after successful completion of work and submission and acceptance of valid calibration certificate with NABL symbol (If applicable) containing the details of traceability and uncertainty of each equipment in the respective batch. 100% Payment shall be made within 21 days after receipt and acceptance of bill for each batch. Bills shall be raised in triplicates in the name of OIC (REC LAB), CMPDI RI VII Bhubaneswar.

14) The tenderer is required to submit GST Identification number/GSTIN certificate.

15) The tenderer is required to submit copy of PAN card.

16) In case the party is not registered for GST, a certificate on that account from a charted accountant must be submitted along with PAN Card.



**Scope of service:**

1. The AMC shall include **three regular visits in one year (once in every four months)** to provide servicing/ maintenance to the instrument.
2. Telephonic assistance: the party will provide telephonic assistance on all days except holidays during office hours.
3. **Complete preventive maintenance**, which includes:
  - Test, Alignment & Adjustment of the equipment's up to the standard performance level.
  - General Checking and cleaning of the equipment.
4. **Service report:** A detailed report of maintenance of the equipment shall be generated during the visit and shall be submitted along with bills.
5. **Calibration** under NABL scope shall be done once in a year in either of these visits as per our requirement. The respective calibration certificates should be provided mentioning the following details:
  - a. NABL symbol are mandatory for all the equipment.
  - b. The error in the equipment may be rectified if possible and the measurement uncertainty along with the error shall be calculated and mentioned in the certificates of each instrument.
  - c. Range of calibration and accuracy of each instrument
  - d. Calibration of equipment shall be done with a master calibrator which should have valid traceability of measurement. The same should be mentioned in the certificates.
6. **Unlimited breakdown visits:** the party shall attend the machine free of cost, in case of any breakdown during the contract period.
7. **Work Location: Talcher, Odisha**
8. The instrument covered under this contract will be made available to the service engineer immediately on his arrival at the site.
9. The AMC shall be operative for **one year** from the date of issue of work order.

10. This contract will not cover defect and damages caused to the instrument due to negligence/improper handling, or due to force majeure causes like lightning, excess voltage, storms, fire, floods, looting/ arson, etc.
11. The contact will not cover project site installations, outside our office. In case, the equipment has been relocated, the same will be brought to the main office or necessary facilities will be provided to the service engineer to reach the site.
12. The costs should be inclusive of travelling charges and other incidental expenses of personnel of the party.
13. Spares if replaced will be charged extra with applicable taxes.

## **Liquidated Damage**

The time frame for carrying out the work shall be the essence of the contract. The period of contract will be 01 years from the date of issue of the work order. If the contractor fails to complete the work on or before the date of completion or extended date of completion, he shall without prejudice to any other right or remedy available under the law to the company on account of such breach, pay as compensation (Liquidated Damages): i) @ half percent (1/2 %) of the contract amount / Revised Contract amount whichever is less, per week of delay, OR ii) ½ % of the contract value of group of items/ revised completion value of group of items whichever is less, per week of delay, for which a separate period of completion is originally given. The aggregate of such compensation/ compensations shall not exceed: i) 10% (ten) percent of the total amount of the contract/ revised contract amount, whichever is less. OR ii) 10% of the contract value of group of items/ revised completion value of group of items whichever is less, for which a separate period of completion is originally given.

In situations where CMPDI is satisfied about reasons for delay, CMPDI may consider request for extension of time without imposition of penalty. The decision of CMPDI in this regard is final and binding. The CMPDI however will not be responsible for any delay on its parts that may be attributed in execution of the work and no claim whatsoever will be entertained on this account.

It is incumbent upon the contractor to avoid litigation and disputes during the course of execution. However, if such disputes take place between the contractor and the department, effort shall be made first to settle the disputes at the company level.

The contractor should make request in writing to the HoD(Environment) CMPDI, RI-VII for settlement of such disputes/ claims within 30 (thirty) days of arising of the cause of dispute/ claim failing which no disputes/ claims of the contractor shall be entertained by the company. Effort shall be made to resolve the dispute in two stages.

In first stage dispute shall be referred to the Regional Director CMPDI, RI-VII Bhubaneswar. If difference still persist the dispute shall be referred to a committee constituted by the CMPDI. The committee shall have one member of the rank of Director of the company who shall be chairman of the committee.

If differences still persist, the settlement of the dispute shall be resolved in the following manner: Disputes relating to the commercial contracts with Central Public Sector Enterprises / Govt. Departments (except Railways, Income Tax, Customs & Excise duties)/ State Public Sector Enterprises shall be referred by either party for Arbitration to the PMA (Permanent Machinery of Arbitration) in the department of Public Enterprises.

In case of parties other than Govt. Agencies, the redressal of the dispute may be sought through Arbitration (THE ARBITRATION AND CONCILIATION ACT, 1996 as amended by AMENDMENT ACT of 2015).

If the parties fail to resolve the disputes/ differences by in house mechanism, then, depending on the position of the case, either the employer/ owner or the contractor shall give notice to other party to refer the matter to arbitration instead of directly approaching Court.

The contractor shall, however, be entitled to invoke arbitration clause only after exhausting the remedy available under the Clause 39.

- i. In case of parties other than Govt. agencies, the redressal of disputes/ differences shall be sought through Sole Arbitration as under.

**Sole Arbitration:**

*"In the event of any question, dispute or difference arising under these terms & conditions or any condition contained in this contract or interpretation of the terms of, or in connection with this Contract (except as to any matter the decision of which is specially provided for by these conditions), the same shall be referred to the sole arbitration of a person, appointed to be the arbitrator by the Competent Authority of CIL / CMD of Subsidiary Company (as the case may be). The award of the arbitrator shall be final and binding on the parties of this Contract."*

- a) In the event of the Arbitrator dying, neglecting or refusing to act or resigning or being unable to act for any reason, or his/her award being set aside by the court for any reason, it shall be lawful for the Competent Authority of CIL / CMD of Subsidiary Company (as the case may be) to appoint another arbitrator in place of the outgoing arbitrator in the manner aforesaid.
- b) It is further a term of this contract that no person other than the person appointed by the Competent Authority of CIL / CMD of Subsidiary Company (as the case may be) as aforesaid should act as arbitrator and that, if for any reason that is not possible, the matter is not to be referred to Arbitration at all.

Subject as aforesaid, the Arbitration and Conciliation Act, 1996 as amended by Amendment Act of 2015 and the rules there under and any statutory modification thereof for the time being in force shall be deemed to apply to the Arbitration proceedings under this clause.

The venue of arbitration shall be the place from which the contract is issued or such other place as the Competent Authority of CIL/ CMD of Subsidiary Company (as the case may be) at his discretion may determine.

**Applicable Law:** The contracts shall be interpreted in accordance with the laws of the Union of India.

**Contracts with Partnership firm/ Joint Venture:**

The Partnership firm/ Joint Venture is required to submit written consent of all the partners to above arbitration clause at the time of submission of bid.

- ii. In case of Govt. agencies, the redressal of disputes/ differences shall be sought through Sole Arbitration as under.

**Sole Arbitration:**

*"In the event of any dispute or difference relating to the interpretation and application of the provisions of the commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port trusts inter-se and also between CPSEs and Government Departments/ Organizations (excluding disputes concerning Railways, Income Tax, Custom & Excise Departments), such dispute or differences shall be taken up by either party for resolution through AMRCD (Administrative Mechanism for Resolution of CPSEs Disputes) as mentioned in DPE OM No. 4(I)/2013-DPE(GM)/FTS-1835 dtd. 22.05.2018".*
