- In case of delay in maintenance, a penalty @ 0.5% per week or part thereof subject to a maximum of 10% shall be imposed and recovered along with applicable GST.

13. **For goods and Services Tax bidder should be submit either of following-**

Scope Of Work

1. The period of work shall be for five months. The job should be immediately started on receipt of this work order. The commissioning date shall be counted from the date of installation and such commissioning of coolers shall have to be certified by the HOD (E&M) or his authorised representative.
2. Air coolers of knight body freshly painted, very good conditioned body, fitted with standard company make 18 inch diameter cooling fan in good condition and minimum water tank capacity of 40L to 50L with all new pads shall have to be provided against hired air coolers.
3. No air coolers with noisy/defective cooling fan, Water pump or defective body shall be accepted for hiring.
4. You have to arrange for installation testing & commissioning of the hired air coolers at different locations as per instruction of the HOD (E&M) or his authorised representative.
5. You have to provide round the clock working for air coolers during Working days, running maintenance, immediate replacement of defective/noisy fans, defective pumps or any other spares etc.
6. You have to send your service attendant within 24 hrs. of registration of complaint by telephonically or written.
7. In case of improper functioning / failure of a hired cooler for more than one day, penalty @twice the rate for per day hiring charge shall be imposed for each day of failure /improper functioning.
8. Monthly bill may be raised for hiring of Air Coolers.
