 - Valid documents of water tanker (truck/tractor)
- Payment- Payment of bill shall be released by HOD(F),CMPDI,RI-1Asansol against submission of bills duly certified by the controlling officer of Gourangdhi Sub camp.
- HSD Supplied by CMPDIL,RI-1,1 ltrs @5KM run km run. Engine oil /lubricants will be born by the contractor with his own cost .
- The Tanker shall be engaged as per requirement of dept. on each day. If required, the vehicle shall be engaged even on Sundays/Holidays. Location of deployment of vehicle may change as per requirement of company.If engagment is more than 12 hrs without night halt at outstation in a day Rs 50/- per hour for engagement beyond 12hrs will be paid extra.
- The tanker must be in tip top & good running conditions and must have proper documents like registration, road tax, insurance, pollution,permit,fitness under control certificate and other satutory papers for the continuing session.
- The driver of this vehicle shall have a valid heavy licence for driving heavy vehicle.Antecedent of the driver must be good and his full home address should be submitted to our office after his engagement as driver. In case the company asks the contractor to remove the driver from duty due to indiscipline, the contractor shall be bound to remove him immediately.
- In case of break-down of the vehicle , replacemnt vehicle must be made available immediately . If alternative vehicle is not provided by you, CMPDIL management shall engage vehicle from other agency at your own cost and risk. In case of non availability of vehicle for use for a day or part of a day for any reasons whatsoever, the hiring charge for that day shall not be payable,or shall be paid on prorata basis for part of the day.
